

INSTRUCTION SHEET

REAR ACCESS PANEL





FLANGE

INSTALLATION

NOTE: Laser Knockouts are provided for the installation of cooling fans, Part No. 5-FAN-K (includes two fans and four guards)

<u>TIP</u>: On 29 rackspace and up enclosures, the power source should be located in the upper half of the enclosure, so that the panel can be removed for servicing, or remove the panel by disconnecting the fan cords from either the fans and/or the power source.

- 1) Rest the bottom flanges of the RAP on the edge of the base.
- 2) Tip up to close.
- 3) Lock to secure in place.

CABLE MANAGEMENT CONSIDERATIONS

Tie fan cords to the enclosure leaving sufficient slack in order to remove the panel and/or to disconnect fan cords from the fans for ease of servicing.
